Student Learning Outcomes (SLOs)

Graded Assignments

Students will meet the learning outcomes outlined above and receive grades through the following:

All written assignments must demonstrate a knowledge of relevant musical terms and concepts and illustrate a basic understanding of the historical and social context in which the works studied arose. Please cite appropriately.

Public Performance Evaluation requires attendance at any classical instrumental performance and a written response describing the aesthetic experience using descriptive imagery and appropriate musical terms. *Please also submit a program with your completed assignment*.

Attendance

As this course possesses a training emphasis, attendance greatly benefits each participant. You are expected to attend all class meetings. I will allow a few exceptions based on life's unexpected surprises. The following are permitted:

Up to 3 Absences for any reason

Absences in excess of the permitted amount will result in a full-grade deduction from your overall score. Tardiness in excess of 10 minutes will be treated as an absence! Please respect your peers and be on time.

*Occasional necessity may require additional absences. Please do not confuse inconvenience with necessity. Excess absences will require documentation such as a signed note from a doctor or the Student Disability Resource Center.

You may take your music home to practice but be sure you have it for each rehearsal. Some of our music must be rented from the publisher at very high cost. This music cannot be lost. If you lose a rental part, you may be financially responsible.

Please bring PENCILS to every rehearsal as well as any accessories you may require such as mutes, swabs, rosin, etc.

Practice

Effective Practice is essential to ensemble success. We will go over some effective practice techniques and hold a mock audition similar to those used for placement in ensembles. This will give you an opportunity to self-evaluate and address concerns regarding your playing.

Naxos Music Library: Access to virtually everything you could ever want to listen to in classical music.

Oxford Music Online: Go here instead of Wikipedia to answer any music questions.

JSTOR: A database of scholarly articles.
