Course description: Class instruction on the violin, viola, cello and bass. Open to all - no previous experience required. This course is a GE activity class that fulfills the lower division Area C requirement. This is a graded course.

In addition to learning basic playing skills and how to read music, instruction will be given on injury prevention and dealing with tensions as they arise in order to maintain physical, mental, and emotional health.

Required materials: Essential Elements 2000, book 1 and a folder for handouts. Instruments for the semester are available through the Music Department for free with a signed instrument checkout form.

Requirements and Grading:

60% of the grade is based on:

- Attendance: you may miss 3 classes for any reason, and no prior email is required. For more than 3 absences, please send e-mail notification *before* class about absences involving illness, or academic/professional responsibilities. More than three unexcused absences could affect your grade. Chronically poor attendance *will* affect your grade due to missed participation, quizzes, evaluations, and tests. Furthermore, *you are required to attend the mid-term, final, and every class during the last two weeks of term in order to prepare for the final. Failure to attend the last 2 weeks of class without a valid excuse will lower your grade by 5 points*
- Participation in class activities involving learning new skills.
- Demonstrations of regular practice. There will be evaluation and quiz days where you will be asked to play assigned work (done in groups, so don't worry!), and skill-demonstrations of (1) the bow hold, (2) the bow strokes, (3) the upper half bow use, (4) the left hand shape, (5) left hand finger action, and last but not least, (6) correct posture

showing good body use (how you sit or stand and hold the instrument). You will be given a practice log to turn in at various times.

- 10% of the grade will be based on your mastery of assigned pieces at mid-term.
- 20% of the grade will be based on the final. 10% is an in-class concert given on the last day of class. 10% is the individual final, where you play alone for me for 5-10 minutes. It is given during finals week. *You must attend both the class final and the individual final in order to pass the class.* The individual final for this class is scheduled for Tuesday, December 12 from 12:40 – 2:30 PM.
- 10% of the grade is based on reports of two musical performances you attend, featuring the instrument you are learning. The reports of about a page in length should include objective observations and subjective reactions based on what you've learned so far. A program or ticket stub must be included with the report. The concerts can be off-campus as well as on. There are many music department concerts listed on bulletin boards. ***You cannot get an A in this class unless you attend 2 performances of the instrument you are learning, and write a short summary or your experience on the performances. Concert reports are due at your individual final.***

It is assumed that 20 – 30 minutes of practice time, four to five times a week will be sufficient to prepare assignments to a good standard of playing. Make-ups for missed, unannounced class quizzes may be made up *if* prior notification of the absence was given, but no make-ups of playing evaluations will be possible.
