Voice Pedagogy Lab (Music 386L)-FALL 2017 Syllabus and Class Outline

HSU Catalog description: Lab practice teaching class and private voice Course format: Activity

The Vocal Pedagogy Lab is for Vocal Performance Majors or General Music Majors with a Vocal Emphasis who have completed or are currently enrolled in MUS 386-Vocal Pedagogy and have completed a minimum of 4 semesters of private vocal study at the university level (or approved equivalent).

Student Learning Outcomes

- Students will demonstrate the ability to teach beginning voice students successfully
- Students will demonstrate piano skills sufficient for playing appropriate vocal exercises and a melody line for singers
- Students will demonstrate knowledge of professionalism within the vocal studio

Additional Class Objectives

- To become familiar with all parts of the singing mechanism and how they function interdependently
- To gain confidence in teaching
- To develop an individualized method for promoting consistent, healthy vocal production for each student
- To identify vocal and musical problems and offer effective solutions
- To explore a variety of literature appropriate for beginning and intermediate level students

Class Meeting Times

- Ten (10) 30-minute weekly lessons to be scheduled individually with your student (When you have scheduled this, I will sign out a room for you.)
- Two 15-minute "mini-lessons" with your student scheduled during the corresponding Vocal Pedagogy Class, MUS 386 (Class meeting times: T/TH 9:00-9:50 AM) and completed in the presence of the instructor and other students in the class
- Consultations to be scheduled on an individual basis with me on an as-needed basis during the course of the semester

Class Requirements

- Develop an outline and syllabus for your student, including your policy for grading & attendance (though they will not actually receive a grade) and all class requirements. We will discuss this during the first weeks of class.
- Keep a record of your weekly lessons including exercises used, problems encountered and your proposed solutions, and your student's progress. You will turn this in to me at the end of the semester.
- Meet with your student individually for a 30-minute voice lesson every week for 10 weeks
- Select and help them prepare appropriate repertoire
- Acquire and hone keyboard skills sufficient for effective vocal teaching

Grading Policy

Your grade will be determined by a combination of:

25% Private Lessons (as evidenced in weekly lesson logs)

25% In-class class mini-lessons (preparedness)

25% Progress in keyboard skills (as demonstrated by piano tests in MUS 386 Vocal Pedagogy)

25% Reasonable progress in vocal "diagnosis" (as evidenced in your Vocal exercises for MUS 386)
