*Course description:* MUS 385p is designed to provide the intermediate & advanced piano students with an opportunity to hone their performance skills. Following the format of a Master Class, students will perform for the class and learn to receive and give constructive criticism. Open discussion regarding all aspects of piano technique, style and performance will allow students the opportunity to discuss and implement various practice methodologies.

*Course Requirements:* Students are required to perform in the seminar frequently as time allows. Participation in seminar discussions is also encouraged and expected. Learning to listen and talk about music is an important aspect of this class. You will also be required to attend all Studio Piano Recitals for the semester as well as four other musical performances (particularly piano events and visiting artists' master classes).
